### 7 SCORING

8.1 To qualify for the series, a skipper must participate in at least 5 of the 8 scheduled regattas. (If only 6 or 7 regattas are held, a skipper must participate in at least 4.)

8.2 The scoring will count the best 5 races using Cox-Sprague high point scoring, including the

'percent perfect' adjustment (points scored / points possible). The final results will be based on percent perfect score, highest to lowest. (If only 6 or 7 regattas are held, the 4 best races will be scored.)
